THIS DEALER AGREEMENT ("Agreement") is between Gold Standard Automotive Network, ("GSAN") a Utah corporation, and							

GSAN appoints Dealer as a sales representative for its Products in accordance with the terms in this Agreement. The term "Product" means any of the Maintenance or Maintenance / Vehicle Service Contract, GAP, or other programs offered by GSAN to Dealer for sale to Dealer's motor vehicle purchasers ("Purchasers").

corporation with its principal offices located at

- 1. **Dealer's Authority**. Dealer is authorized to sell Products to Purchasers in the states where GSAN is authorized. Dealer shall only sell Products at prices and for eligible vehicles as determined by GSAN as of the time of the sale of the vehicle. Dealer shall (a) sell Products only for vehicles in good mechanical condition at the time of sale, (b) repair any defects in the vehicle as of the time of sale, and (c) indemnify GSAN from any claims arising out of any defect in any vehicle.
- 2. **Right to Change Product Terms, including Dealer Rate; Duty to Comply with Rules**. GSAN may change Product terms, including the Dealer rate, at any time. Dealer shall promptly make the changes upon notice and shall at all times comply with GSAN's instructions and rules.
- 3. **Funds, including Taxes**. Dealer will hold all funds received for GSAN Products in trust. GSAN can deduct any amounts owed by the Dealer from what's owed to them. Dealer must pay GSAN immediately upon receiving an invoice, except for payments on sold Products, which are due by the 15th of the following month. If the Dealer fails to pay on time, they're responsible for all related claims and costs. GSAN's insurer can collect owed funds directly from the Dealer. The Dealer is responsible for any taxes related to GSAN Products and bears its own expenses, not incurring any on GSAN's behalf.
- 4. **Dealer Has No Authority to Settle Claims and Shall Not Provide Repair Services**. Dealer shall have no authority to adjudicate or settle any claim and shall direct Purchasers to GSAN for claims.
- 5. **Dealer's Disclosures to Purchasers.** Dealer shall fully inform all Purchasers of the terms of any GSAN Product before sale.
- 6. **Cancellation**. GSAN may decline or cancel any GSAN Product Contract in its sole discretion subject only to the terms of the Contract and applicable law.
- 7. **Indemnification**. Dealer shall hold GSAN, including its agents and successors, harmless from any claim relating to a GSAN Product Contract except a claim by a Purchaser against GSAN for failure to perform its obligations under Product Contract. Dealer shall notify GSAN within two business days of learning of any claim of any kind relating to a GSAN Product.

- 8. **Confidential Information**. Dealer shall not disclose GSAN's Confidential Information, which includes all information provided by GSAN to Dealer, including information concerning business and practices, rating information, policies and procedures, techniques, processes, equipment, software programs, financial information, pricing policies, contractual relationships, and sales, among other things. Dealer shall use Confidential Information only for the purposes of fulfilling its duties under this Agreement.
- 9. **Compliance with Applicable Law; Licenses.** Dealer shall comply with applicable laws relating to this Agreement and the Products and shall maintain in good standing all required licenses and permits.
- 10. **Protection of Privacy**. Except as required herein, Dealer shall not disclose information concerning any Purchaser without first affording GSAN a reasonable opportunity to confirm that such disclosure complies with applicable law.
- 11. **No Discrimination**. Dealer shall not engage in unlawful discrimination, misrepresentation, or any unfair trade practice or practice prohibited by law.
- 12. **Termination**. This Agreement may be terminated by either party upon written notice. Termination shall not affect the parties' rights and duties with respect to Contracts sold before termination. Upon termination, Dealer shall cease offering the Products and coordinate with GSAN to resolve any issues or disputes with Purchasers.

The Dealer must document that a total loss occurred. Also:

- The purchase or lease of the replacement vehicle from the Dealership must be for an amount greater than the value prior to the loss of the replaced vehicle.
- The vehicle that has been totaled must be replaced at your Dealership.
- Vehicles that are repairable but deemed by the Customer as totaled are not eligible for this Dealer plan.
- The payment shall be made to the Dealer with the Customer's name on the check. The Dealer shall validate the sale or lease before the check is released.
- The following documents are required when filing a claim: (1) the Customer's Insurance Carrier's Total Loss Summary Letter, (2) the Customer's Bill of Sale / Purchase Agreement of the replacement vehicle.

### **DEALER NO CHARGEBACKS**



The parties hereto have previously entered into an Administrative Agreement setting forth their rights and duties with respect to a Service Contract Program administered by the Administrator.

IN CONSIDERATION of mutual agreements herein contained being kept and performed, Administrator agrees to allow the Dealer to retain profits on canceled Mechanical Vehicle Service Contracts, providing the following conditions are met:

- 1. (a) In the event of cancellation of an approved service contract by the purchaser after One Hundred Twenty (120) days from its effective date, the amount of the refund by Administrator will be the full pro rata amount due to the purchaser, subject to 1e below.
  - (b) A refund due to a cancellation of an approved service contract within One Hundred Twenty (120) days of its effective date will be shared by both the Dealer and Administrator. Each party will pay their appropriate pro rata share of the refund. The Dealer's pro rata share is based on the difference between the retail selling price and the Dealer net cost due to the Administrator including a surcharge.
  - (c) All approved service contracts written as of Your notice date, shown above shall be subject to this addendum.
  - (d) Administrator's responsibility to the Dealer will not exceed the pro rata share of the refund based on the Dealer's service contract profit and where applicable may NOT exceed the approved state filed rates.
  - (e) The Maximum dollar amount of this "Dealer No Chargeback" is the actual cost up to a maximum of One Thousand Dollars (\$1,000). Dealer Pass Through, Over Bill, Over Remit etc. are included in the dealer's portion of the One Thousand Dollars (\$1,000) covered by Gold Standard Automotive Network, Inc.
- 2. The No Chargeback Agreement can be modified or terminated by the Administrator at any time. A Dealer may also terminate the No Chargeback agreement. Termination of this Addendum will not be grounds for termination of the Administrator agreement. If this Agreement is terminated, all contracts written while this Addendum is in force will be subject to and accounted for pursuant to the terms herein.
- 3. Except as herein specified, all other terms and conditions of the Administrator Agreement, and any Addendum or amendment thereto, remain unchanged.
- 4. Any contract financed through Paylink and Line 5, do not qualify for the No Chargeback program. Each party will pay their appropriate pro rata share of the refund. The Dealer's pro rata share is based on the difference between the retail selling price and the Dealer net cost due to the Administrator including surcharge.

WHEREAS, Dealer is in the business of selling new and/or used automobiles and desires to sell Motor Vehicle Service Agreements, or Vehicle Service Contracts ("VSCs" or "VSC") to its customers under the Gold Standard Automotive Network, Inc. VSC program ("VSC Program") designed and administered by PWC; and

WHEREAS, Dealer recognizes that PWC has expertise in administering VSCs; and

WHEREAS, PWC desires to assist Dealer by maintaining and administering the VSC Program for the benefit of Dealer and its VSC purchasers.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants herein contained, and other good and valuable consideration not herein mentioned, the parties hereto agree as follows:

#### 1. DEALER AGREES:

- a. To obtain and maintain any license(s) required by the Florida Office of Insurance Regulation to sell Motor Vehicle Service Agreements. Dealer shall be solely responsible for its compliance with all licensing requirements and agrees to immediately notify PWC of its licensed individuals or entities so that PWC can arrange for their appointment.
- b. To offer to its customers VSCs on a form approved in writing by PWC. Each approved VSC shall be sold only in respect to a vehicle qualifying therefore, and only in accordance with and subject to PWC's programs, coverages, rules, regulations and fees indicated on the attached Exhibit A- Retail Rates. PWC may at any time revise its programs, coverages, rules, regulations, and fees, and Dealer shall promptly conform to any such revisions. PWC shall not be obligated to perform administrative services with respect to any VSC sold by Dealer on a form which has not been approved by PWC or the use of which has been discontinued by PWC or otherwise sold in violation of this Agreement. Dealer shall have no authority to alter, modify, waive, or discharge any terms or conditions of any VSC Program or approved VSC, nor to incur any liability on behalf of PWC, nor to make representations about VSC coverage not contained in the VSC.
- c. To remit to PWC funds representing the Dealer Cost (retail rate less dealer commission), relating to each VSC sold by the Dealer within fifteen (15) days after the end of the month in which the Dealer issues the VSC along with a properly executed copy of such VSC. Dealer shall document and disclose to PWC all rebates, coupons, rewards or other discounts applied to the Retail Rate relating to each VSC sold. Any additional monies due for such VSCs will be due immediately upon Dealer's receipt of a Dealer Billing Statement.
- d. To refund to any lender who has financed the purchase price of a VSC the Dealer's retained portion of the amount financed by the lender in the event of (i) the cancellation of a VSC at the lender's request, (ii) due to a total loss or repossession of the covered vehicle, or (iii) due to a default by the VSC holder in repayment obligations to the lender. If a canceled VSC was not financed, Dealer agrees to refund to the purchaser a portion of that part of the total retail price of the VSC, such portion to be determined by PWC in accordance with the terms of the VSC and applicable law. Dealer shall be solely responsible for remitting the full amount of any cancellation refund to the purchaser of the canceled VSC or any other party entitled to receive such refund under the applicable law or regulation.
- e. To notify PWC and to receive PWC's approval prior to making any repairs or replacements under any VSC.
- f. That PWC may periodically adjust the Retail Rate and any adjustment shall take effect thirty (30) days after receipt of notice by Dealer. If Dealer fails to properly remit funds to PWC for any VSC issued by it, Dealer shall indemnify and hold PWC harmless from, and shall promptly reimburse PWC for, all costs and expenses of PWC resulting from Dealer's failure to remit such funds. Such costs and expenses may include, without limitation, the costs of vehicle repair, the Dealer Cost, and cancellation refunds. The failure of Dealer to properly remit funds for any VSC issued by it shall constitute a material breach of this Agreement.

- g. That PWC reserves the right to offset any amounts Dealer owes PWC, or any of its affiliates, from any amount PWC owes Dealer.
- h. Until payment is delivered to PWC, to deduct the dealer costs from the proceeds of each VSC sold and to hold said funds in a fiduciary capacity as trustee for, and under conditions satisfactory to, PWC.
- i. To submit to PWC all claims for reimbursement within ninety (90) days after completion of repairs. No such claim will be submitted for an amount greater than that authorized by PWC. Dealer further agrees not to submit to PWC or insurer named on VSCs, any claims for reimbursement for (i) repairs of components or parts not covered by an approved VSC, (ii) repairs or expenses expressly excluded or not covered by the terms and conditions of an approved VSC, (iii) repairs or expenses resulting from the failure of Dealer to perform repairs in a good and workmanlike manner, (iv) repairs or replacements of parts or components to correct conditions existing or which may reasonably be assumed to have existed at the time the covered vehicle was sold, and (v) repairs or expenses which are also covered by a manufacturer's warranty, a dealer's or repairer's guarantee, or a vehicle service contract or similar agreement not administered by PWC. Dealer agrees that any improper claim submission may be rejected by PWC, and such claim will be solely the responsibility of Dealer.
- j. To use its commercially reasonable best efforts to market the VSC Program, and to faithfully perform in every way its duties in compliance with the instructions of PWC.
- k. To unconditionally guarantee services provided under VSCs against defects in workmanship and materials, under normal use, for a period of 90 days or 3,000 miles after the date of service, whichever comes first.
- 1. That, in the event that PWC declines to issue a VSC to a purchaser, to either correct the deficiency which caused the declination and to resubmit the VSC to PWC, or, if the deficiency cannot be corrected in accordance with PWC's requirements, to timely refund to the purchaser any fees tendered with respect to such VSC.
- m. To indemnify and hold harmless PWC (including its officers, directors, employees, agents, representatives, successors and assigns) from any and all claims, actions, demands or liabilities (including, but not limited to, attorney's fees and other legal costs) of any type arising out of, or resulting from, (i) any act or failure to act by Dealer (including its officers, directors, employees, agents, representatives, sales personnel, mechanics, and contractors or sub-contractors) which causes harm or damage to any person or property, (ii) any act related to the conduct of Dealer business over which PWC has no control; (iii) any other claim arising out of or related to a VSC except to the extent that such claim relates to PWC's failure to perform its obligations thereunder, or (iv) Dealer's failure to comply with any and all applicable laws, rules, regulations, and ordinances respecting the sales of VSCs.
- n. To assume full responsibility for repairing, replacing, or paying for any failed part covered by a VSC when such failure occurs within the first thirty (30) days after the effective date of the VSC or within the first 1,000 miles driven after the effective date of the VSC, whichever occurs first.

#### 2. PWC AGREES:

- a. To maintain and administer the VSC Program for Dealer.
- b. To use its commercially reasonable best efforts to provide a Motor Vehicle Service Agreement under applicable Florida laws or regulations.
- c. To furnish Dealer with VSC forms and other supplies approved by PWC necessary for Dealer to implement the VSC Program, all of which shall remain the property of PWC and shall be returned to it in the event of the termination of this Agreement or upon demand of PWC.
- d. To investigate, process, and adjust claims covered by the VSC in accordance with the then current claims adjusting procedures and to reimburse all such claims which are processed and presented to PWC by Dealer in the manner required by PWC and this agreement.
- e. To compute payment to Dealer on all covered VSC claims at the approved Dealer labor rate based on the customers contract and for the time required per the industry recognized manual used by the PWC (e.g., Chilton).

- f. In the event of cancellation of the VSC, all applicable fees received by PWC and Dealer in connection with such contract will be refunded per the terms of the VSC.
  - 1. In the event of cancellation of the VSC by the purchaser within sixty (60) days from the effective date of the contract, and provided no repair work has been covered by the contract, PWC will refund to the Dealer, or a party designated by the Dealer, the full amount of the contract fee paid to PWC for the cancelled contract.
  - 2. In the event of cancellation of the VSC by the purchaser after sixty (60) days from the effective date of the contract, or if repair work was performed or commenced within the first sixty (60) days from the effective date of the contract, PWC will refund 100% of the unearned premium paid, less a fee of ten percent (10%) of the refund amount, less any claims pending or paid.
    In the event a VSC is canceled due to legal repossession outside any recourse period stipulated in the Dealer's finance agreement with a lending institution which financed the purchase of such contract, PWC may refund the contract fee and additional fees received, as provided above, directly to such lending institution.

#### 3. TERMINATION:

- a. Either party may terminate this Agreement for any reason upon thirty (30) days written notice. Either party may terminate this Agreement immediately upon the discovery of fraud or material breach of the Agreement by the other party, its agents, or employees. Termination for fraud or material breach shall be effective upon receipt of written notice by the non-terminating party.
- b. This Agreement shall terminate automatically without notice from PWC if a petition of bankruptcy is filed by or against Dealer, or if Dealer shall have made an assignment for the benefit of creditors, or shall have been voluntarily adjudicated bankrupt by any court of competent jurisdiction, or if a petition for reorganization of Dealer, or if an arrangement with creditors is filed by or against Dealer, or if a receiver shall have been appointed for all or a substantial part of Dealer's business, or if Dealer shall have permitted or suffered any attachment, levy, or execution agreement, or if at any time Dealer fails to remit to PWC the full amount of the Dealer Cost due in connection with the issuance of a VSC.
- c. Termination of this Agreement shall not alter PWC's responsibility to administer claims under VSCs for which PWC has received payment prior to the effective date of termination of Dealer's obligations to perform under VSCs then in force.

#### 4. MISCELLANEOUS:

- a. This Agreement contains the entire agreement between the parties and supersedes any and all previous or contemporary arrangements between the parties. All future changes must be made in writing and signed by both parties.
- b. The validity, interpretation, and performance of the Agreement shall be controlled by and construed under the laws of the State of Tennessee.
- c. All notices, demands, or communications regarding this Agreement shall be in writing, signed by the party serving the same, and deposited, postage prepaid in the United States Postal Service as certified or registered mail to the appropriate address indicated herein.

- d. If any provision of this Agreement is held invalid under the law or regulations of any state where used, such provision shall be deemed not to be part of this Agreement in such state but shall not invalidate any other provision hereof.
- e. PWC shall have full and free access during business hours at Dealer's office(s), or place where Dealer's records are kept, to inspect books, records, and files relating to the business covered by the VSC Program under this Agreement.
- f. This Agreement is not assignable by Dealer without the written consent of PWC and shall not be construed to make Dealer an agent, expressed or implied, or an employee of PWC.
- g. Customer Information: PWC and Dealer agree to not disclose or use nonpublic personal information about consumers or customers that it receives from the other party except (i) to carry out the purposes for which the other party disclosed such information; or (ii) as otherwise permitted by law as an exception to the notice and optout requirements established under Title V (Privacy) of the Gramm-Leach-Bliley Act and regulations promulgated pursuant thereto, or other state or federal law or regulation. Both parties agree to apply the protections of an appropriate and effective information security program to such information as may be required by law.






